**How to Enter:** During the promotional period, take the rideshare pledge at [pt.berkeley.edu/rideshareweek](http://pt.berkeley.edu/rideshareweek). Upon submitting your pledge you will receive (1) entry into the drawing.

For additional entries you may register for Berkeley Moves! ([cal.rideamigos.com](http://cal.rideamigos.com)) through the pledge form or on the [cal.rideamigos.com](http://cal.rideamigos.com) website. For each green trip logged on the Berkeley Moves! calendar you will receive (1) entry into the drawing. A valid green trip only includes all modes available on [Cal.Rideamigos.com](http://Cal.Rideamigos.com) website except driving alone and telecommuting.

**Limit:** One pledge entry per person via the pledge survey. One entry per two trips on through the Commuter Calendar.

**Drawing:** Cal Parking and Transportation will randomly select Twenty-Five winner from all eligible contest entries received by November 8 at 11:59 p.m. Cal Parking staff will notify the potential winners for their prize via the email address provided to Cal Parking by the participant. A minimum of three attempts will be made to contact the winners using the contact information provided. If the designated winner does not claim the prize within Seven (7) days of the date of the first attempt of contact, that winner shall forfeit receipt of the prize.
